Contest Period

The contest begins at 12:00 am (central time) January 1, 2019 and ends at 12:00 pm (central time) on December 31, 2019. Entries must be received by 12:00 pm on December 31, 2019 to be eligible for a prize drawing.

Eligibility

1. No purchase necessary to win. You do not need to have an account at BankStar Financial. Utilizing any other bank services will not improve your chances of winning.
2. The contest is open to individuals 18 years of age or older who are legal residents of the United States at the time of entry.
3. Employees of BankStar Financial (and household family members) are not eligible to participate.
4. The contest is void where prohibited by law.

Automatic Entry

1. BankStar Financial customers who enroll in eStatements, and customers already enrolled in eStatements, will automatically be entered in the contest during the promotional period and will receive one (1) entry per enrolled account.
2. Enrollment is complete upon the acceptance of the electronic statement terms & conditions disclosure and entering the four (4) digit confirmation code. This allows you to receive your statements electronically in lieu of paper statements via US Mail.
3. New enrollments must take place between January 1, 2019, and December 31, 2019, to be entered in the contest.

Alternate Method of Entry

1. To enter by mail: print your name, address, and phone number on a 3 x 5 card and send to: BankStar Financial, PO Box A, Elkton, SD 57026.
2. Limit one mailed entry per person.
3. All entries must be received by December 31, 2019.
4. Illegible or incomplete entries will be disqualified.
